The Kansas legislature ended the governor's emergency declaration on 6-15-2021. In accordance with the KS Legislative directive, CDC and KDHE guidelines are no longer in force. Any guidance now comes from the county health department.

(A) Universal and correct wearing of masks.

USD #342 highly recommends the usage of masks...

USD #342 plans to return to customary practices of placing students in classes, lunchroom assignments, and movements throughout the building during the day.

USD #342 highly encourages handwashing, sanitizing, and respiratory etiquette. Hand sanitizer will be made available.

(D) Cleaning and maintaining healthy facilities, including improving ventilation.

USD #342 is committed to maintaining healthy facilities. USD #342 will continue to thoroughly clean all facilities on a regular basis using approved cleaning solutions and disinfectants. PlasmaAir needlepoint bipolar ionization devices have been installed in classrooms to improve air quality. Ventilation systems are monitored for proper function.

(E) Contact tracing in combination with isolation and quarantine, in collaboration with the State, local, territorial, or Tribal health departments.

USD #342 will continue to follow the guidelines set forth by the Jefferson County Health Department and the Kansas State Health Department as the situations dictate.

USD #342 will provide the opportunity for testing of staff and students who are considered close contacts of a COVID positive individual. This is a voluntary program and students or staff must opt-in to participate. In addition, USD #342 will continue to work with the Jefferson County Health Department, Oskaloosa, 785-403-0025, for diagnostic and screening tests.

(G) Efforts to provide vaccinations to school communities.

USD #342, in coordination with the Jefferson County Health Department, provided all school staff members the opportunity for vaccinations. USD #342 will continue to partner with the Jefferson County Health Department to ensure that convenient safe and accessible locations are available for all patrons.
